## 1. Introduction

Willow Primary School, as part of the **Exceed Learning Partnership**, is committed to providing a broad and balanced curriculum that promotes the spiritual, moral, social and cultural development of all pupils. Religious Education (RE) plays a key role in this vision by fostering understanding, respect and tolerance for diverse beliefs and worldviews.

## 2. Statutory Requirements

As an academy, we have the freedom to follow any approach, however, we follow the **2025 Doncaster Agreed Syllabus for Religious Education** because it meets the legal requirements as outlined in the Education Act 1996 and provides clear guidance for delivering a high-quality RE curriculum that is locally agreed and nationally informed.

## 3. Aims of Religious Education

The purpose of RE at Willow Primary School is to support pupils in becoming **reflective, respectful and informed learners**. Our RE curriculum enables pupils to:

- **Know and understand a range of religions and worldviews**, developing a secure and meaningful understanding of key beliefs, practices, and values.
- Express ideas and opinions about belief and meaning in thoughtful and respectful ways.
- Develop critical thinking skills and the ability to reflect on their own beliefs, values and experiences.
- Recognise the importance of gaining a good understanding of different faiths and worldviews in order to build empathy, challenge prejudice and promote shared values.
- Become tolerant and respectful individuals who appreciate diversity within their local community and the wider world.
- Engage positively with religious and non-religious perspectives, learning to live respectfully and responsibly in a multicultural and multi-faith society.

## 4. Curriculum Delivery

- RE is taught **weekly as a discrete subject** across all year groups.
- We follow the **2025 Doncaster Agreed Syllabus**, which ensures balanced coverage of Christianity and other principal religions such as Islam, Hinduism, Sikhism, Judaism and non-religious worldviews.
- Lessons include learning about beliefs, practices, celebrations, special places, and moral teachings.
- The curriculum is enhanced through the use of **faith visitors, visits to places of worship**, storytelling, artefacts and high-quality visual resources.
- Teaching is inclusive and sensitive, promoting discussion and encouraging respect for all.

## 5. Inclusion and Accessibility

RE is provided to all pupils, regardless of background or ability. Lessons are adapted to meet the needs of all learners, including pupils with SEND, and we ensure that all children can access and engage meaningfully with the content.

## 6. Right to Withdraw

In line with statutory guidance, parents and carers have the **right to withdraw** their child from all or part of RE. Any requests should be made in writing to the Principal and a meeting will be offered to discuss alternative arrangements.

We always take parents views into account but strongly advocate children participating in RE regardless of their own faith so that all our children have a strong understanding of a range of ideas and faiths within society.

## 7. Assessment and Monitoring

- Teachers assess learning through observations, discussions, and recorded work, using guidance from the Doncaster Agreed Syllabus.
- The **RE Lead** monitors planning, teaching and learning across the school, and supports staff with training and resources.

## 8. Resources and Enrichment

We use a range of engaging resources to support learning in RE, including:

- Artefacts, books, and videos from a variety of faith traditions.
- Guidance materials from the **2025 Doncaster Agreed Syllabus**.
- Links with local faith communities, guest speakers, and trips to places of worship.

## 9. Review and Policy Oversight

This policy will be reviewed every three years or sooner if there are significant changes in local or national guidance.

Oversight of RE sits with the **academy's leadership team**, the **RE Lead**, and is supported by the **Exceed Learning Partnership Trust Board** where appropriate.

Year Group	Key Themes	Religions/Worldviews Covered
<b>EYFS</b>	Celebrations, special people, belonging, stories	Christianity, introduction to other beliefs (e.g. festivals from Hinduism, Islam)
<b>Year 1</b>	Belonging, places of worship, religious stories	Christianity, Judaism
<b>Year 2</b>	Leaders and teachers, special books, symbols	Christianity, Islam
<b>Year 3</b>	Community, worship, sacred texts	Christianity, Hinduism
<b>Year 4</b>	Pilgrimage, festivals, teachings	Christianity, Sikhism
<b>Year 5</b>	Beliefs and actions, moral choices, life journeys	Christianity, Islam, Humanism
<b>Year 6</b>	Belief in action, identity, comparing worldviews	Christianity, Non-religious worldviews (e.g. Humanism)
